1	From drift to draft: How much do beneficial mutations actually contribute to

#### 14 Abstract

Since its inception in 1973 the slightly deleterious model of molecular evolution, 15 aka the Nearly Neutral Theory of molecular evolution, remains a central model to 16 explain the main patterns of DNA polymorphism in natural populations. This is 17 18 not to say that the quantitative fit to data is perfect. In a recent study CASTELLANO 19 et al. (2018) used polymorphism data from D. melanogaster to test whether, as 20 predicted by the Nearly Neutral Theory, the proportion of effectively neutral 21 mutations depends on the effective population size (N<sub>e</sub>). They showed that a 22 nearly neutral model simply scaling with N<sub>e</sub> variation across the genome could 23 not explain alone the data but that consideration of linked positive selection 24 improves the fit between observations and predictions. In the present article we 25 extended their work in two main directions. First, we confirmed the observed 26 pattern on a set of 59 species, including high quality genomic data from 11 27 animal and plant species with different mating systems and effective population 28 sizes, hence *a priori* different levels of linked selection. Second, for the 11 species 29 with high quality genomic data we also estimated the full Distribution of Fitness 30 Effects (DFE) of mutations, and not solely the DFE of deleterious mutations. Both 31 Ne and beneficial mutations contributed to the relationship between the 32 proportion of effectively neutral mutations and local Ne across the genome. In 33 conclusion, the predictions of the slightly deleterious model of molecular 34 evolution hold well for species with small N<sub>e</sub>. But for species with large N<sub>e</sub> the fit 35 is improved by incorporating linked positive selection to the model.

## 40 Introduction

41

The year 2018 saw the celebration of the 50<sup>th</sup> anniversary of the Neutral Theory 42 43 of molecular evolution (called simply the Neutral Theory thereafter). At 50 years 44 of age, the Neutral Theory is still shrouded in controversies, some pronouncing it 45 dead and overwhelmingly rejected by facts (Kern and Hahn 2018) while others 46 see it as very much alive and kicking (Nei et al. 2010; Jensen et al. 2019). As a 47 quick glance at major textbooks in population genetics and at the literature 48 would suggest, it seems fair to say that the Neutral Theory is certainly not totally 49 dead. Even if it undoubtedly did lose some of its initial appeal it continues to play 50 a central role in population genetics, a position well summarized by Kreitman 51 (1996) in his spirited essay "The neutral theory is dead. Long live the Neutral Theory". Shortcomings of the Neutral Theory were already noted in the 1970s 52 53 and the Neutral Theory has itself evolved. Indeed, its inadequacy to fully explain 54 the data, in particular the constancy of the molecular clock, was already noted in 55 1973, leading Tomoko Ohta (1973) to propose the Nearly Neutral Theory of 56 molecular evolution. In contrast to the Neutral Theory where most mutations are 57 assumed to be neutral or strongly deleterious, the Nearly Neutral Theory assigns 58 much more prominence to the contribution to standing polymorphism of 59 mutations that are weakly selected and effectively neutral (Ohta 1992; Ohta and 60 Gillespie 1996). Weakly selected mutations can be slightly deleterious or slightly beneficial, but as noted by Kreitman (1996) the best developed of the weak 61 62 selection models primarily considers slightly deleterious mutations and was 63 therefore christened by him "the slightly deleterious model". This is the model 64 that we will be testing in most of the present paper.

Like the Neutral Theory, however, the Nearly Neutral Theory still assumes that "only a minute fraction of DNA changes in evolution are adaptive in nature" (Kimura 1983). Under this view, polymorphism is thought to be mostly unaffected by positive selection, except around the few recently selected beneficial alleles (selective sweeps). This was already at variance with the view put forward by Gillespie (e.g. Gillespie 2004) that assigned a greater role to linked positive selection in shaping polymorphism (see also CORBETT-DETIG *et al.* 

73 2015) and is in even stronger contrast with the claim by Kern and Hahn (2018) 74 that "natural selection has played the predominant role in shaping within- and between-species genetic variation" and that "the ubiquity of adaptive variation 75 76 both within and between species" leads to the rejection of the universality of the 77 Neutral Theory. In a far more nuanced assessment of the Neutral Theory and its 78 contribution, Jensen *et al.* (2019) argued that the effects of linked selection could 79 readily be incorporated in the Nearly Neutral framework. The heart of the 80 dispute, either today or in the early days of the Nearly Neutral Theory, is about 81 the degree to which each category of mutations contributed directly and 82 indirectly to genetic variation within- and between-species.

84 A core prediction of the Nearly Neutral Theory is that the fraction of mutations 85 affected by selection depends on the effective population size, N<sub>e</sub> (Ohta 1973). N<sub>e</sub> is a measure of (the inverse of) genetic drift and corresponds to the size of an 86 87 ideal, typically Wright-Fisher, population generating the same amount of drift as the observed population. The definition of Ne depends on the drift-related 88 89 process (ex: inbreeding, variance in allelic frequencies) and the time scale of 90 interest. The coalescent effective population size is relevant for prediction of 91 polymorphism patterns (Sjödin et al, 2005). Ne can vary among species (because 92 of difference in population size, variance in fecundity, reproductive systems...) 93 but also along a genome because linked selection generates variation in the 94 coalescent process if recombination rate and selection targets are not uniformly 95 distributed (reviewed in Ellegren and Galtier 2016). The effect of selection 96 against deleterious mutations on linked neutral variants – background selection 97 (Charlesworth *et al.* 1993) – is often modeled by a simple re-scaling of  $N_e$  but 98 except in specific situations effects of linked selection are more complex and 99 there is not a single re-scaling (Barton 1995; Zeng 2013; Comeron 2017; Cvijovic 100 et al. 2018; Torres et al, 2019). In the case of beneficial mutations, for instance, 101 the interference depends both on the beneficial effect of the sweeping mutation 102 and on selection acting at linked sites (Barton 1995; Weissman and Barton 2012). 103

Evidence that linked positive selection and not only direct selection on slightlydeleterious and beneficial mutations contributed to the relationship between the

106 fraction of mutations affected by selection and N<sub>e</sub> has recently been obtained by 107 Castellano et al. (2018). Using two Drosophila melanogaster genome re-108 sequencing datasets, Castellano et al. (2018) tested a prediction of the slightly 109 deleterious model first obtained by Kimura (1979) and then extended by Welch et 110 al. (2008). Welch et al. (2008) showed that if one considers only deleterious 111 mutations, the logarithm of the ratio of nucleotide diversity at non-synonymous 112 and synonymous amino acid changes is linearly related to the logarithm of the 113 effective population size and that the slope of this log-log regression line is equal 114 to the shape parameter of the Distribution of Fitness Effects (DFE),  $\beta$ , if the DFE 115 of deleterious mutations is modeled by a Gamma distribution:

117  $ln(\pi_N/\pi_S) \approx -\beta ln(N_e) + constant$  [Eq. 1a]

118

119 where  $\pi_N$  is the nucleotide diversity at non-synonymous sites and  $\pi_S$  is the 120 nucleotide diversity at synonymous sites.

122 Or, rewriting this expectation by using  $\pi_s$  as a proxy for N<sub>e</sub>:

123

124  $ln(\pi_N/\pi_S) \approx -\beta ln(\pi_S) + constant'$  [Eq. 1b]

125

126 The second equation holds only if variation in  $\pi_s$  solely depends on variation in  $N_{e}$ , and that there is no correlation between the mutation rate and N<sub>e</sub>. It should 127 128 also be pointed out that the DFE used here only considers deleterious mutations, 129 as estimated for instance by DFE-alpha (Eyre-Walker and Keightley 2009). A 130 direct test of this prediction using among-species comparison can be problematic 131 if mutation rates cannot be controlled for. To circumvent this problem, 132 Castellano *et al.* (2018) used within genome variation in N<sub>e</sub>, under the reasonable 133 assumption that variation in mutation rates are negligible compared to variation 134 in  $N_e$  across a genome. They found (see also James et al. 2017) that the slope was significantly steeper than expected under a simple scaling of N<sub>e</sub> and simulations 135 136 indicated that linked positive selection, but not background selection, could explain this discrepancy. The effect of linked selection on the relationship 137 138 between  $\pi_N/\pi_S$  and  $\pi_S$  is twofold. First it increases stochasticity in allele

139 frequencies, or, in other words, decreases the local effective population size. 140 Second, linked selection leads to non-equilibrium dynamics. Genetic diversity 141 will recover faster for deleterious than neutral mutations, altering the 142 relationship between  $\pi_N/\pi_S$  and  $\pi_S$  (Brandvain and Wright, 2016; Do et al. 2015; 143 Gordo and Dionisio 2005; Vigué and Eyre-Walker 2019). More precisely, the more a region is affected by selective sweeps, the lower  $\pi_s$  is and the higher 144  $\pi_N/\pi_S$  is compared to the equilibrium expectation: this effect makes the slope 145 146 steeper compared to the equilibrium expectation.

147

148 In the present paper, we first confirmed the observed pattern on the set of 59 149 species used in Chen et al. (2017). We then used 11 high quality genomic 150 datasets for which an outgroup is available to test whether the results obtained by Castellano *et al.* (2018) hold more generally and, in particular, in species with 151 152 much smaller effective sizes than *D. melanogaster*, and with different levels of 153 linkage disequilibrium. While we adopted the same general approach than 154 Castellano et al. (2018), our analysis differed from theirs in one important 155 respect. In their study, Castellano et al. (2018) only characterized the DFE of 156 deleterious mutations. We, instead, used a newly developed approach, *polyDFE* 157 (Tataru *et al.* 2017), that also considers positive mutations, which is expected to 158 improve the estimation of the shape of the DFE of deleterious mutations and to 159 disentangle the direct effects of both positive and negative selection.

- 161 Material & Methods

# 163 Genomic data and regression of $\pi_N/\pi_S$ over $\pi_S$

164

In a first step we re-analyzed the 59 species from Chen *et al.* (2017), which included 34 animals and 28 plant species. We estimated the DFE using folded site frequency spectra with the same method as in Chen *et al.* (2017) and calculated the slope (regression coefficient of  $log(\pi_0/\pi_4)$  over  $log(\pi_4)$  as described in the next paragraph (we used 0-fold degenerated sites for the calculation of genetic diversity at nonsynonymous sites and 4-fold degenerated sites for synonymous sites. The same estimates are used in the rest of the paper). For DFE estimation 172 using folded SFS the model assumes a gamma distribution for deleterious 173 mutations and takes demography (or sampling or any departure from 174 equilibrium) into account by introducing *n*-1 nuisance parameters for an SFS of 175 size *n* (the corresponding code was provided in Chen *et al.* (2017)). In later 176 analyses that required unfolded site frequency spectra, we retained 11 species 177 with high quality genomic datasets and with an available outgroup. These eleven 178 species are given in Table 1. They include both animal and plant species with 179 contrasted levels of nucleotide polymorphism and mating systems. For each of 180 the eleven species, we aligned short reads to the genome using BWA-mem (Li 181 and Durbin 2010) and sorted the alignment using SAMtools. PCR duplicates were 182 removed and INDELs were realigned using GATK toolkit (McKenna et al. 2010). 183 HaplotypeCaller was used for individual genotype identification and joint SNP calling 184 was performed across all samples using GenotypeGVCFs. Variant and invariant sites were kept only if genotypes of all individuals were successfully identified 185 186 (Carson et al. 2014). We collected Single Nucleotide Polymorphism (SNPs) in all 187 CDS regions and calculated genetic diversity of 4-fold and 0-fold degenerated 188 sites as proxies for polymorphism at synonymous  $(\pi_s)$  and non-synonymous 189 sites ( $\pi_N$ ). Sites were all masked with 'N' and excluded from further computation 190 in the following five cases: heterozygous sites in selfing species, sites with more 191 than two variants, variants at sites within five bases of a flanking INDEL, variants 192 sites with GQ<20, and missing individuals. We applied the same SNP sampling 193 strategy as in James et al. (2017) and Castellano et al. (2018) in order to remove 194 potential dependency between estimates of  $\pi_0/\pi_4$  and  $\pi_4$ . In brief, we first split 195 all synonymous SNPs into three groups (S1, S2, and S3) following a 196 hypergeometric sampling process in R based on the total number of synonymous 197 sites (see formula 3-6 in Castellano et al 2019). To bin genes and reduce the 198 difference in number of SNPs in each bin, we ranked genes according to their 199 Watterson's estimate of nucleotide diversity ( $\theta_{S1}$ ) and grouped these ranked 200 genes into 20 bins each representing approximately 1/20 of the total number of 201 synonymous SNPs. We then used  $\pi_{S2}$  to estimate the  $\pi_0/\pi_4$  (we summed  $\pi$  over 202 all genes and scaled by the total length to get  $\pi_0$  and  $\pi_4$  for each bin) ratio and  $\pi_{S3}$ 203 as an independent estimate of the genetic diversity of each bin.

205 We calculated the slope of the linear regression (*l*) of the log-transformed value 206 of the  $\pi_0/\pi_4$  ratio on the log-transformed value of  $\pi_4$ , using the "lm" function in R 207 (R Core Team 2018). In pilot runs on 59 species (population data of Chen et al. 208 (2017)), the estimates of *l* showed extensive variation depending on, among 209 other things, the qualities of genome sequencing, read depth, annotation and SNP 210 calling. Thus, we selected 11 species for which a high-quality genome sequence 211 and an outgroup were available. Individuals were selected from the same genetic 212 background, i.e. admixture or population structure were carefully removed. At 213 least 20 alleles (i.e. 10 individuals for outcrossing species or 20 for selfing species) were retained from a single ancestral cluster defined in 214 215 Admixture/Structure analysis in the original publication. For the two *Capsella* 216 species, we performed Admixture analysis for both species separately. A series 217 of quality controls for *l* calculation were performed as described in the following. 218 The longest transcript for each gene model was kept only if it contained both 219 start and stop codons (putative full length) and no premature stop codons. SNPs 220 flanking five bases of INDEL were masked to avoid false positive calls. A grid of 221 filtering criteria (see details in Table S2) was also implemented on each species 222 based on sequence similarity against Swiss-Prot database (e-value, bit-score, 223 query coverage) and sequencing quality (sites with low read depth or ambiguous 224 variants). We selected the filtering criteria in order to maximize the adjusted  $R^2$ 225 in the log-log regression of  $\pi_0/\pi_4$  on  $\pi_4$ . By doing so we aimed to reduce the error 226 introduced by annotation and quality difference between model and non-model 227 organisms. Also, to evaluate the variance introduced by random sampling and 228 grouping of SNPs, we performed 1,000-iteration bootstraps to get the bootstrap 229 bias-corrected mean and 95% confidence intervals for *l* calculations.

# 231 Estimates of the distributions of fitness effects

232

The distribution of fitness effects (DFE) for all non-synonymous mutations across the genome was first calculated by considering only deleterious mutations. We first re-used the DFE parameters estimated in 59 animal and plant species in Chen *et al.* (2017) that assumes that only neutral and slightly deleterious mutations contribute to genetic diversity. In brief, in this previous 238 study the DFE was modeled using a gamma distribution with mean  $S_d$  and shape 239 parameter  $\beta$ . Folded site frequency spectra (SFS) were compared between 240 synonymous and nonsynonymous sites and demography (or any departure from 241 equilibrium) was taken into account by introducing n-1 nuisance parameters for 242 an unfolded SFS of size *n*, following the method proposed by Eyre-Walker *et al*. 243 (2006). The possible issues and merits of this approach compared to those 244 based on an explicit (albeit very simplified) demographic model have been 245 discussed previously and the method introduced by Eyre-Walker et al. (2006) 246 has proved to be relatively efficient (Eyre-Walker and Keightley 2007; Tataru et 247 al. 2017). The calculations were carried out using an in-house Mathematica script implementing the method of Eyre-Walker et al. (2006) provided in 248 249 supplementary S2 file of Chen et al. (2017).

250 However, for species with large effective population sizes, like *D. melanogaster*, 251 ignoring the effects of beneficial mutations could distort the DFE to a great 252 extent and lead to a wrong estimate of  $\beta$ . Therefore, we further estimated the 253 DFE under a full model that takes both deleterious and beneficial mutations into 254 account (Tataru et al. 2017) using unfolded SFS for 11 species. Briefly, the model mixes the gamma distribution of deleterious mutations (shape= $\beta$ , mean= $S_d$ ) with 255 256 an exponential distribution of beneficial mutations (mean= $S_b$ ), in proportions of  $(1-p_b)$  and  $p_b$ , respectively. The unfolded SFS was calculated for the 11 retained 257 species, for which a closely related outgroup with similar sequencing quality was 258 259 available to polarize the SFS. Ancestral state was assigned as the state of the 260 outgroup if the outgroup was monomorphic for one of the two variants, and the 261 derived allele frequency was calculated from this polarization. Otherwise (in the 262 case of missing data, polymorphic site or third allele in the outgroup) the site was masked. The percentage of SNPs that could not be polarized and were 263 264 masked varied between 0 and 29.3% with a mean of 4.6% and a median value of 265 0.5% (Table S2).

266 In addition, since polarization errors could remain, the error rate of the ancestral state assignment ( $\varepsilon_{an}$ ) was also taken into account in *PolyDFE*. The "gamma" DFE 267 268 (that only considers deleterious mutations) and the full DFE were estimated for 269 each species. In both cases a nuisance parameter was also fitted to account for 270 possible mis-assignment errors in SNP ancestral allele estimation (a step 271 required to obtain the unfolded SFS). Note that, although we used outgroups to 272 polarize SFSs, we did not use divergence but only polymorphism to estimate the 273 effect of beneficial mutations. This is at the cost of larger variance in estimates 274 but it avoids the (potentially strong) bias due to ancient variations in  $N_e$  that 275 cannot be captured by modeling recent changes in population size (Rousselle et 276 al. 2018). When comparing the estimates of the DFE among several species, the 277 problem arises that the best model is not necessarily the same for all species (the 278 best model can include or not beneficial mutations and include or not 279 polarization errors). Comparisons cannot be fairly done if all species do not 280 share the same model. Alternatively, estimations under an over-parameterized 281 model can lead to large variance and extreme values. To circumvent this problem, 282 we used a model averaging procedure where each parameter of interest ( $\beta$ ,  $S_b$ ,  $S_d$ , 283 and  $p_b$ ) is estimated as a weighted mean of estimates obtained under four models: 284 the Gamma DFE and the full DFE models, including polarization errors or not. The weights given to the estimate from model k is  $w_k = e^{-1/2\Delta AIC_k}$  where 285  $\Delta AIC_m = AIC_m - AIC_{min}$  with AIC being the Akaike Information Criterion and 286 AIC<sub>min</sub> the minimum AIC among the four models (Posada and Buckley 2004). All 287 288 calculations were performed using the software *polyDFE* and the associated R 289 script (Tataru et al. 2017). A goodness-of-fit test was carried out by comparing 290 observed SFS to expected SFS under Gamma DFE or full DFE model for each SNP

291 category, respectively. P-values were calculated under a  $\chi^2$  distribution with the

292 number of degrees of freedom equal to n (total number of SNP categories) – 2

293 (synonynmous and non-synonymous sites).

# 295 Expectations under different selection models

296

Independently of possible indirect effects of selective sweeps, [Eq. 1] only considers deleterious mutations, in line with the initial view of the Nearly Neutral Theory where beneficial mutations negligibly contribute to polymorphism (Ohta 1973). Giving more weight to beneficial mutations slightly modified the relationship between the slope of the linear regression, *l*, and the shape parameter,  $\beta$ . For beneficial mutations only, the equivalent of [Eq. 1] is simply (see Appendix):

305  $ln(\pi_N/\pi_S) \approx +\beta_b ln(N_e) + constant$  [Eq. 2]

307 where  $\beta_b$  is the shape of the distribution of beneficial mutations, still assuming a 308 gamma distribution, so  $\beta_b$  would be 1 in the statistical framework we used. Thus, 309 the  $\pi_0/\pi_4$  ratio increases with  $N_e$ , so that considering beneficial mutations the 310 global  $\pi_0/\pi_4$  decreases more slowly than when only deleterious mutations are 311 taken into account. Thus, with beneficial mutations the slope will always be 312 lower than without. For the majority of species beneficial mutations are rare  $(p_h \ll 1)$  and thus b (thereafter we define b = -l) is approximately equal to  $\beta$ . For 313 314 those with a relatively high proportion of beneficial mutations, direct positive 315 selection should result in a flattened slope, i.e. a smaller value of b than  $\beta$ . As we 316 mostly observed the reverse pattern,  $b > \beta$ , the observed discrepancy cannot be 317 explained by the direct effect of beneficial mutations.

318

319 Trends across the genome and tests for selection

320

321 For each of the 20 bins defined above and ranked according to their mean 322 synonymous nucleotide diversity we calculated  $\beta$ ,  $p_b$  and  $S_b$  values and a 323 summary statistic of the site frequency spectrum, Tajima's D (Tajima 1989). 324 Tajima's D tests for an excess of rare over intermediate variants compared to the 325 frequencies expected under the standard coalescent and was calculated from 326 synonymous sites Demography does affect Tajima's D and can explain the 327 difference among species. However, a negative Tajima's D is also expected under 328 recurrent selective sweeps (Jensen et al. 2005; Pavlidis and Alachiotis 2017) and 329 should be more negative in genomic regions more strongly affected by linked 330 positive selection. Background selection can also affect Tajima's D in the same 331 direction but much more weakly (Charlesworth et al. 1995). Independently of 332 the species mean value, we thus expect a strong positive relationship between 333 recombination and Tajima's D in species where linked positive selection is 334 prominent.

335

#### 336 Forward simulations under selective sweep scenario

337

The code developed by Castellano et al (2018) which is based on forward 338 339 simulations using the software SLiM, version 3.2.1 (Haller and Messer 2019) was modified to assess the effect of parameters  $p_b$ ,  $S_b$ , and N on b and Tajima's D. 340 More specifically, a 20-kb genomic region was simulated with a mutation rate of 341 342 1x10<sup>-6</sup> to study the behavior of *b* and Tajima's D under selective sweep scenarios 343 with varying parameters of  $p_b$ ,  $S_b$ , and N. First, we simulated equal amounts of 344 neutral and deleterious mutations whose fitness effects were drawn from a gamma distribution with a shape parameter 0.4 and a mean  $S_d$  of -10. Different 345 346 percentages of beneficial mutations ( $p_b$  = 1%, 0.8%, 0.5%, 0.4%, 0.3%, 0.2%, 347 0.01%, 0.005% and 0) were drawn randomly from a distribution with a fixed  $S_b$ 348 of 1 to simulate loci experiencing selective sweeps at different frequency and we 349 then calculated b (Fig. 5 of Castellano et al (2018)) and Tajima's D. We also 350 investigated the behavior of b and Tajima's D by varying s<sub>b</sub> (1, 0.5, 0.1), N (100, 351 500, 1000) and the recombination rate (Nr=0, 1e-3, 1e-2). Simulated values were 352 averaged across 50 samples, which were taken every 5N generations after an 353 initial burn-in period of 10N generations.

354

355 **Results** 

#### 357 b and $\beta$ are generally similar but the variance is large

358

359 One of the most important predictions of the Nearly Neutral Theory is that the 360 proportion of effectively neutral mutations is a function of the effective population size (Kimura and Ohta 1971; Ohta 1972; Ohta 1973; Ohta 1992). In 361 362 species with large effective population size, selection is efficient and the proportion of effectively neutral mutations is small. Here we used the ratio of 363 364 genetic diversity at 0-fold over 4-fold degenerate sites  $(\pi_0/\pi_4)$  in protein coding 365 regions as a measure of the proportion of effectively neutral mutations and examined the linearity between  $\log(\pi_0/\pi_4)$  and  $\log(\hat{N}_{e})$  across the genomes of 366 59 species used in Chen et al. (2017). The slope (linear regression coefficient 367 between  $\log(\pi_0/\pi_4)$  and  $\log(\hat{N}_{\rho})$  was negative for 51 of the 59 species (*l*<0), 368 369 although it was significantly different from zero at p=0.05 in less than half of the 370 species (28/59). The value of l varied from -0.424 (D. melanogaster) to 0.22 371 (*Callithrix jacchus*) (Table S1). Since balancing selection can lead to both high  $\pi_4$ 372 and  $\pi_0/\pi_4$ , it can generate an increase in  $\pi_0/\pi_4$  for high- $\pi_s$  bins. We thus removed 373 the five bins with the highest diversity and recalculated *l* values for all species. 374 This reduced the *l* values of 36 species and led to negative *l* values in 55 species.

375

376 We further examined the DFE for mutations across the genome in the same 377 datasets. A gamma distribution with two parameters, mean  $(S_d)$  and shape  $(\beta)$ , 378 was used to describe the distribution of deleterious mutations under purifying 379 selection. Importantly, the contribution of beneficial mutations, even those under 380 weak selection that are potentially behaving neutrally, is ignored in this case. 381 Estimates of the shape parameter,  $\beta$ , varied from 0.01 (*C. jacchus*) to 0.347 (*D.* 382 *melanogaster*) but were only weakly correlated with effective population size 383 (Table S1).

384

385 Considering only deleterious mutations and assuming a simple scaling of  $N_e$ 386 variation across the genome, the slightly deleterious model predicts that the

value of the slope of the linear regression between  $\log(\pi_0/\pi_4)$  and  $\log(\hat{N}_e)$ , b 387 388 (recall that b = -l), is equal to  $\beta$  (Welch *et al.* 2008). The discrepancy between the 389 two might indicate a departure from this model, and Castellano et al. (2018) 390 suggested that in *D. melanogaster*, where the observed slope was steeper than 391 expected, the departure was caused by linked positive selection across the 392 genome. We observed a general consistency between  $\beta$  and b as estimators of 393 effective neutrality (linear coef. = 1.04, intercept=0.007, p-value<2e-16, adjusted 394 R<sup>2</sup>=0.35, Fig. 1A). The difference ( $\Delta = b - \beta$ ) was small in 40 species and varied 395 from -0.1 to 0.1 (Fig. 1B). In 36 species (61%) b values were larger than  $\beta$  and in 396 23 species (39%)  $\beta$  was larger than b. However, the variation in  $\Delta$  was not 397 explained by  $\pi_s$  or N<sub>e</sub> as the adjusted R<sup>2</sup> was only 0.06. Removing the five bins 398 with the highest diversity, the correlation between  $\beta$  and *b* was still significant 399 (coef. 0.89, p-value=2.14e-6). The median value of  $\Delta$  increased from 0.0085 to

400 0.045 but there was still no correlation between  $\Delta$  and  $\hat{N}_{\rho}$ .

401

# 402 The effects of quality control and full DFE model

403

404 The variation in  $\Delta$  may come from two sources. First, it can be due to the 405 estimation quality of b and  $\beta$ . Tests have shown that quality control on 406 sequencing and SNP-calling can have a dramatic influence on *b* calculations and 407 ignoring beneficial mutations in DFE model could also distort the estimates of  $\beta$ 408 (Tataru *et al.* 2017). Second, the variation in  $\Delta$  can be caused by departures from 409 the assumptions underlying the simple version of the Nearly Neutral Theory, for 410 instance, a larger role of direct or linked positive selection than assumed by the 411 theory.

412

413 To assess the relative importance of these two sources we selected 11 species 414 with genomic data of high quality and performed a series of stringent quality 415 controls (see details in M&M) before re-estimating *b*. This improved the 416 goodness of fit for the log linear regression between  $\pi_0/\pi_4$  and  $\pi_4$  across the 417 genome and *b* estimates were significantly different from zero for all 11 species 418 (Table 1 and Fig. 2, see also details in Table S2 and Fig. S1-S3 for correlation 419 between  $\pi_0/\pi_4$  and  $\pi_4$  and between  $\pi_0$  and  $\pi_4$  in linear and log scales). For 420 estimating  $\beta$ , we used closely related species to polarize the SFS and applied both 421 the gamma DFE model and the full DFE model implemented in *polyDFE*, which 422 considers both deleterious and beneficial mutations. Instead of choosing the best 423 DFE model, an average value weighted by the different models' AIC scores was 424 calculated for each parameter (Tataru and Bataillon 2019).

425

In this case we observed a better correlation between *b* and  $\beta$  (Pearson's correlation rho = 0.727, p-value=0.011) than when we considered the 59 species and used only a gamma DFE. In addition, considering beneficial mutations slightly increases  $\beta$  estimates, making them closer to *b*. However, the linear coefficient between *b* and  $\beta$  (1.26) is significantly higher than one and the variation of  $\Delta$  remains large (-0.026 ~ 0.289) suggesting that some additional factors may lie behind the remaining variation.

433

## 434 The roles of effective population size and positive selection

435

We then tested if the variation in  $\Delta$ , where  $\Delta = b - \beta$ , could simply reflect differences in effective population size (N<sub>e</sub>) among species. Estimates of N<sub>e</sub> were obtained by rescaling  $\pi_s$  using estimates of the mutation rate ( $\mu$ ) from the literature (see Table S3 for the sources of the  $\mu$  estimates). When  $\Delta$  is regressed against log( $\hat{N}_e$ ), log( $\hat{N}_e$ ) explained up to 49% of the variance in  $\Delta$  (pvalue=0.014). Considering the uncertainty in  $\mu$ , we also regressed  $\Delta$  on log( $\pi_s$ ), and obtained similar results (R<sup>2</sup>=0.41, p-value=0.019, Fig. 3).

443

Furthermore, we tested whether species with potentially more selective sweeps show higher  $\Delta$ , as predicted by Castellano *et al.* (2018). An explicit model of selective sweeps is difficult to fit given the uncertainty about beneficial mutations parameters and would require additional information, especially on the recombination map of the different species. Alternatively, we qualitatively reasoned that, in addition to be more frequent when the effective population is large, the number of selective sweeps should increase with both the proportion 451  $(p_b)$  and the mean strength of beneficial mutations  $(S_b)$ . Log $(S_b)$  had a significant and positive effect on  $\Delta$  (p-value=0.0018, Fig. 3) and explained 64.3% of the 452 453 variance in  $\Delta$  but the effect of  $p_b$  was not significant (p-value=0.29). When considered together, the effects of both  $\log(S_b)$  and  $\log(\pi_4)$  (or  $\hat{N}_a$ ) in the joint 454 455 model explained up to 78% of the variance in  $\Delta$  (p-value=0.0068 and 0.059, 456 respectively, Table 2). However, no significant effect of  $p_b$  could be detected 457 either in the single regression model (p-value=0.29) or joint model with other 458 variables (p-value=0.15). The rate of adaptive evolution relative to the neutral 459 mutation rate,  $\omega_a$  (Galtier 2016) combines the proportion ( $p_b$ ) and the mean strength of beneficial mutations ( $S_b$ ) according to  $\omega_a = p_S \times S_b / (1 - \exp(-S_b))$ . 460 However, as for  $p_b$  the effect of  $\omega_a$  on  $\Delta$  was not significant (p-value=0.17) 461 462 although the relationship is positive as expected.

463

We also conducted goodness-of-fit tests for both Gamma DFE and full DFE 464 465 models by comparing the difference between the observed SFS to that simulated 466 under both DFE models, respectively (Fig S4, Table S4). For all 11 species, the 467 expected SFS under the full DFE model showed a better or as good fit to the data 468 as the one under the Gamma DFE model (higher or equal *p*-values), especially for 469 species like *C. grandiflora*, *D. melanogaster*, *S. habrochaites*, *S. huaylasense* and *P.* 470 *trichocarpa* where either  $p_b$  or  $S_b$  could not be ignored. Overall, the full DFE 471 model predicted the observed SFS with less than 5% error (Figure S4).

472

473 Trends across the genome and tests for selection

474

Variation of DFE parameters across bins could also explain the difference 475 476 between  $\beta$  and b since the underlying assumption is that  $\beta$  is constant across bins. 477 We thus calculated  $\beta$  for all 20 bins for the 11 species. Seven species had  $\beta$  values 478 increasing weakly with genetic diversity (p-value<0.05, mean regression 479 coefficient 0.056) while *C. grandiflora* and *H. timareta* had a much faster increase 480 (regression coefficient =0.2 and 0.15, respectively, Table 3). In five species, the 481 slope was steeper than the maximum  $\beta$  value, similar to what was obtained by 482 Castellano et al. (2018) in Drosophila. However, the slope was shallower than the

483 maximum  $\beta$  value in the six remaining species and in five of them the maximum  $\beta$ value was larger than 1 (Table 1). We also compared  $p_b$  and  $S_b$  values across bins. 484 In A. thaliana  $p_b$  increased slowly with diversity whereas in C. grandiflora, S. 485 486 *huaylasense*, and *D. melanogaster*  $p_b$  decreased significantly (p-value<0.05). In all 487 11 species, *S*<sup>*b*</sup> did not show any significant trend across bins. To more formally 488 test for the significance of these variations, we also divided the genomes into five 489 bins (to get enough power per bin) and tested the invariance of the DFE across 490 bins using likelihood ratio tests as implemented in *polyDFE*. For all species, a 491 model with independent DFE parameters for each bin is significantly better than 492 a model with shared parameters across bins (see Table S5).

493

494 For all 11 selected species we also calculated Tajima's D (Tajima 1989), thereafter simply called D, in each bin to test for departure from neutrality 495 496 across the genome. Mean values of D were slightly negative across bins for most 497 species except *S. habrochaites*. For nine of the eleven species, D values increased 498 significantly with genetic diversity (Table 3). Interestingly, we found a negative 499 and strong correlation of Tajima's D with  $log(S_b)$  for all 11 species (Pearson's 500 correlation rho. =-0.74, p-value=0.0086) but not with any other DFE parameters. 501 This is in agreement with the expectation that selective sweeps decrease D. 502 Background selection could also decrease D albeit to a lower extent. We further 503 tested the trends of positive and negative selection by calculating the 504 proportions of deleterious or beneficial mutations over all bins with selective 505 strength <-10 and >10, respectively. However, no significant trends were identified for either type of direct selection. 506

507

We also tested whether alternative measures of the possible occurrence of selective sweeps could explain a larger part of the variation in  $\Delta$ . We used both the mean Tajima's D and the among-genome regression coefficient of the relationship between D and  $\pi_{\rm S}$  ( $\rho_{\rm D}$ ) as predictors. More negative D and stronger positive regression coefficient between D and  $\pi_{\rm S}$  can be viewed as signature of stronger hitchhiking effects. So we would expect to see a negative effect of D and a positive effect of  $\rho_{\rm D}$  on the variation in  $\Delta$ . In combination with  $\pi_4$  (or  $\hat{N}_a$ ), both

515 D and  $\rho_D$  indeed explained a significant part of the variation in  $\Delta$  (adjusted 516 R<sup>2</sup>=0.76, Table 2).

517

518 Simulations

519

520 Castellano et al. (2018) used forward simulations to assess the extent to which selective sweeps made the slope the relationship between  $\log(\pi_0/\pi_4)$  and  $\log(\hat{N}_a)$ 521 522 steeper and thereby could explain the discrepancy between the slope and the 523 shape parameter of the DFE,  $\beta$ . They tested varying proportions of adaptive 524 mutations (their Fig. 5). We extended their investigation to test the effect of 525 selective strength ( $s_b$ ) on b with a fixed  $\beta$  (0.4) and how selective strength ( $s_b$ ) 526 also affected estimates of Tajima's D. Without recombination (Nr=0), Fig. 4 shows that when  $s_b$  increased from 0.1 to 1, b increased from 0.46 to 0.72 527 528 ( $\Delta$ =0.06 to 0.32). As expected mean Tajima's D decreased from -0.36 to -0.77 as 529  $s_b$  increased and  $\rho_D$  between D and  $\pi_4$  increased (see also Table 4). We also 530 increased N from 100 to 500, and to 1000, and fixed the mean selective strength at either  $S_b = 10$  or  $S_d = -1000$ . With these parameters, the strength of selection 531 532 was not affected by N but the number of sweeps increased with N due to the 533 higher input of (beneficial) mutations. In this case  $\Delta$  increased from 0.06 to 0.41 534 as N increased and Tajima's D again decreased (Table 4 and Fig. 5). With 535 recombination (Nr=1e-3 and Nr=1e-2), we noticed similar trends of *b*, D, and  $\rho_D$ 536 when *s*<sub>b</sub> or N are large enough to recover the significance of the linearity between  $\log(\pi_0/\pi_4)$  and  $\log(\pi_4)$  (Fig. S5 and S6). 537

538

# 539 Discussion

540

541 The aim of the present study was to test quantitatively one of the predictions of 542 the Nearly Neutral Theory of molecular evolution or, more precisely, the slightly 543 deleterious model. More specifically, we used full genome datasets to test 544 whether the proportion of effectively neutral mutations varies with local 545 variation in  $N_e$  across the genome and decreases linearly with increasing  $N_e$  and 546 whether the slope is equal to the shape parameter of the DFE. The negative log 547 linear relationship between  $\pi_0/\pi_4$  and N<sub>e</sub> observed in previous studies (Gossmann et al. 2011; Murray et al. 2017; Castellano et al. 2018; Vigué and 548 549 Eyre-Walker 2019) was also observed in the present study, although the slope 550 was not always significantly negative and, when negative, could differ 551 significantly from the shape parameter of the DFE and be much steeper. The 552 latter was especially true in species with large effective population size and the 553 difference was correlated to the estimated mean strength of selection acting on 554 beneficial mutations. In the case of species with large effective population size 555 neglecting linked positive selection could therefore lead to a significant 556 quantitative discrepancy between predictions and observations. On the other 557 hand, the slightly deleterious model appears as a good approximation when the 558 effective population size is small. Below we first consider possible caveats and 559 discuss the implications of the results for the relative importance of purifying 560 and adaptive selection in shaping the genetic diversity of species.

561

562 The discrepancy between the slope of the log linear relationship between  $\pi_N/\pi_S$ 563 and N<sub>e</sub> and  $\beta$  could simply be due to difficulties in estimating them precisely. In 564 general, estimates of the DFE shape parameter,  $\beta$ , were rather stable compared 565 to estimates of the slope of the regression of  $\log(\pi_0/\pi_4)$  over  $\log(\pi_4)$ , *b*, with the variance of the former being half that of the latter independently of quality 566 567 control and whether the SFS was folded or unfolded. High variation in b 568 estimates may explain the fact that a significant correlation between  $\pi_0/\pi_4$  and 569  $\pi_4$  could not be observed for all species, particularly those with low genetic 570 diversity (e.g. great apes). Therefore, a stringent quality control for read 571 alignment and SNP calling is necessary, even for *D. melanogaster*, where an 572 improvement of the fit in *l* calculation (linear regression adjusted  $R^2=0.79$  to 0.95) 573 leads to a dramatic change in the estimate of  $\Delta$  (from 0.077 to 0.29). Even if a 574 stringent quality control had been implemented, the goodness of fit for the log 575 linear regression leading to the estimation of *b* would differ significantly from 576 species to species. The fit across the *D. melanogaster* and *A. thaliana* genomes 577 was almost perfect (R<sup>2</sup>>0.95) while, at the other extreme, the fit was rather poor 578 in *S. habrochaites* (R<sup>2</sup>=0.38). However, even among species for which the fit is 579 almost perfect ( $R^2 > 0.95$ ) b could vary rather dramatically: D. melanogaster had a

580 much larger l (0.7) than A. thaliana (0.48), C. rubella (0.43), and Z. mays (teosinte, 581 0.29), whereas  $\beta$  only changed marginally for these species. Not all species though showed a significant negative linear relationship between  $\pi_0/\pi_4$  and  $\hat{N}_a$ 582 583 and some even had positive slopes, especially for those of low diversity (e.g. 584 great apes, Fig 2). Therefore, besides purifying selection the slope is also likely to 585 be affected by additional factors. Factors that affect the likelihood to observe a negative relationship between  $\pi_0/\pi_4$  and  $\hat{N}_e$  and its relationship with the DFE 586 587 parameters were thoroughly discussed by Castellano et al. (2018). Below we 588 highlight those that seem particularly relevant when considering a group of 589 species with contrasted levels of diversity as was done here. These factors are 590 the variation in N<sub>e</sub> estimates along the genome, which itself reflects the joint 591 distribution along the genome of recombination rate and density of selected sites, 592 the DFE, and the variation along the genome of the rate of adaptive evolution 593 (Castellano et al. 2018).

594

595 Lack of joint variation in recombination rate and selected sites seems to be an 596 unlikely cause for an absence of negative relationship between  $\pi_0/\pi_4$  and N<sub>e</sub> as 597 such a relationship is observed in selfing species where this joint variation is 598 expected to the more limited than in outcrossing ones. A possible source of 599 variance in  $\beta$  could be that the single-sided gamma distribution does not describe 600 well the real DFE curves, at least not for all species, particularly when the DFE is 601 not unimodal (Tataru et al. 2017). For species like D. melanogaster, for instance, 602 there is mounting evidence of adaptive evolution (reviewed in Eyre-Walker 2006, 603 Sella et al. 2009). Therefore, it is necessary to consider the possible contribution 604 of beneficial mutations. The full DFE model provided a much better fit than the 605 gamma DFE that considers only deleterious mutations in *D. melanogaster* (log 606 likelihood= -187.3 versus -245.7, respectively). This was also true of some of the 607 outcrossing plants like Capsella grandiflora, and Solanum huaylasense. In all three 608 species  $\beta$  estimates increased when estimated with the Full DFE instead of the 609 Gamma DFE, sometimes significantly (from 0.33 to 0.41 in D. melanogaster 610 (Rwanda) and 0.15 to 0.31 in *S. huaylasense*) and at other times only marginally (0.27 to 0.30 in *C. grandiflora*). Taking beneficial mutations into account when 611

612 fitting the shape of the DFE can partly reduce the discrepancy between  $\beta$ 613 estimates and the slope of the regression. However, it is not sufficient as  $\Delta$  was 614 positive in 10 over the 11 focal species we studied.

615

616 Based on the prediction of the Nearly Neutral Theory with direct positive 617 selection (Equation 2), the proportion of beneficial mutations is the only factor 618 that could alter the relationship between *b* and  $\beta$  and should always result in a 619 larger  $\beta$  compared to b. However, this is usually not the case as, on the contrary, 620 values of *b* larger than  $\beta$  have generally been reported (Chen *et al.* 2017; James *et* 621 al. 2017; Castellano et al. 2018). In this paper we systematically investigated this relationship across the genomes of multiple species. Two thirds of the 59 species 622 623 and 10 out of the subset of eleven species that were selected for the high quality 624 of their genome, had larger *b* than  $\beta$  values. Hence direct positive selection is not 625 the main cause of the discrepancy.

626

Investigation of DFE parameter changes across bins may help to identify changes 627 628 in natural selection. Increasing  $\beta$  values over bins could be a signal for stronger positive selection in low diversity regions. Although the maximum  $\beta$  value of 629 some species can be larger than b,  $\beta$  grows slowly for most species and shows 630 631 hardly any pattern between species. Neither did  $p_b$  or  $S_b$ . This lack of significant 632 trend in these parameters could simply be due to an increase in variance of their 633 estimates as only one twentieth of the total number of polymorphic sites were 634 used for DFE calculations in each bin. It could also again suggest that direct 635 selection is not the main cause of the discrepancy.

636

637 One of the main findings of the present study is that a large proportion of 638 variance in the discrepancy can be explained by the estimated strength of 639 positive selection, which can be regarded as an indication for linked selection, 640 such as selective sweeps or more generally hitchhiking effects. To test for that, we compared changes in Tajima's D and its among-genome correlation 641 642 coefficients over bins. As expected we observed a negative effect of D and a 643 positive effect of  $\rho_D$  on  $\Delta$ , both suggesting the presence of linked selection, with 644 lower diversity at nearby sites and thus increased discrepancy between b and  $\beta$ .

645 This is also in agreement with our simulations and those of Castellano et al. 646 (2018) that illustrate that hitchhiking effects can lower the genetic diversity at 647 nearby neutral or nearly neutral positions. These results can be understood 648 because selective sweep effects cannot simply be captured by a rescaling of N<sub>e</sub>. 649 Selective sweeps not only reduce genetic diversity at linked sites but also distort 650 the coalescent genealogy (Fay and Wu 2000; Walsh and Lynch 2018; Campos 651 Parada and Charlesworth 2019), so that we cannot define a single  $N_e$  in this 652 context (Weissman and Barton 2012). In particular, the scaling is not expected to 653 be the same for neutral or weakly selected polymorphisms. However, as far as 654 we know, there is no quantitative model predicting the value of the slope as a function of DFE, rates of sweep and recombination rates, and such models still 655 656 need to be developed.

657

#### 658 **Conclusions**

659

There are three major conclusions to the present study. First, the Nearly Neutral 660 Theory in its initial form may not explain all aspects of polymorphisms but, 661 almost 50 years after it was first proposed by Tomoko Ohta (Ohta 1973), it still 662 constitutes an excellent starting point for further theoretical developments 663 664 (Galtier 2016; Walsh and Lynch 2018). Second, considering linked beneficial selection indeed helps to explain more fully polymorphism data, and this is 665 666 especially true for species with high genetic diversity. This can explain both patterns of synonymous polymorphism (Corbett-Detig et al. 2015) and how 667 668 selection reduces non-synonymous polymorphism (Castellano et al. 2018, this 669 study). One could have a progressive increase of the effect of selective sweeps as 670 suggested by Walsh and Lynch (2018, chapter 8) with a shift from genetic drift to 671 genetic draft (Gillespie 1999; 2000; 2001). If so, we could have three domains. 672 For small population sizes, drift would dominate and the nearly neutral theory in 673 its initial form would apply. For intermediate population sizes beneficial 674 mutations would start to play a more important part, and finally for large 675 population sizes, the effect of selective sweeps would dominate and draft would 676 be the main explanation of the observed pattern of diversity. Third, our study once more emphasizes the central importance of the DFE in evolutionarygenomics and we will likely see further developments in this area.

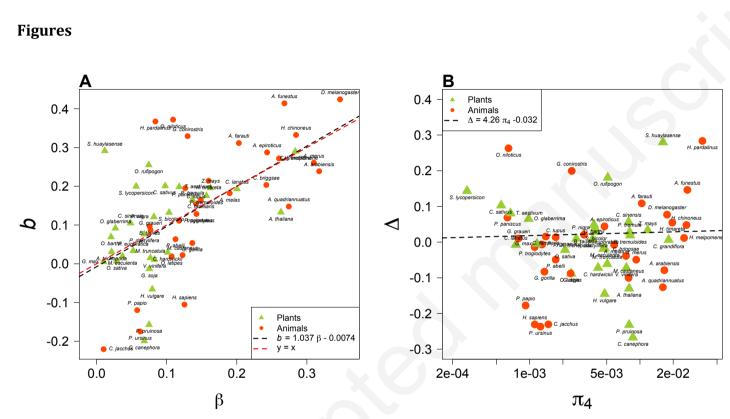
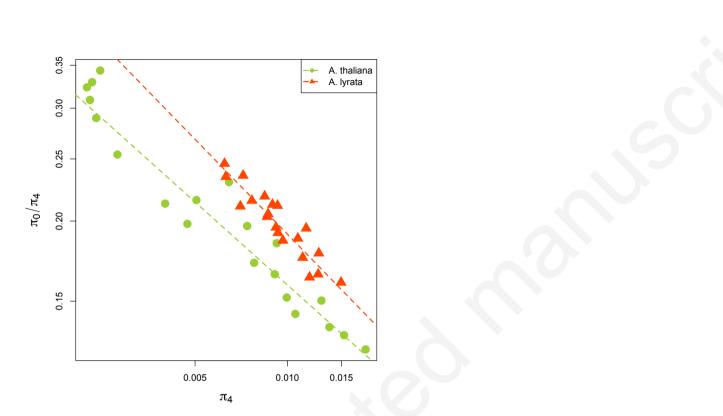
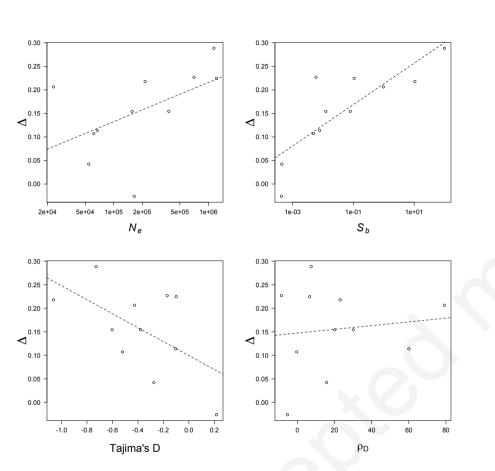


Fig. 1 (A) The correlation between *b* and the shape parameter of the DFE, *β*, from the 59 species in Chen *et al.* (2017). The observed slope of the regression of  $log(\pi_0/\pi_4)$  over  $log(\pi_4)$ , *l*=-*b*. (B) The distribution of  $\Delta$  (=*b*-*β*) against genetic diversity at synonymous sites. *β* values were estimated from DFE models with only deleterious mutations considered (the gamma distribution).

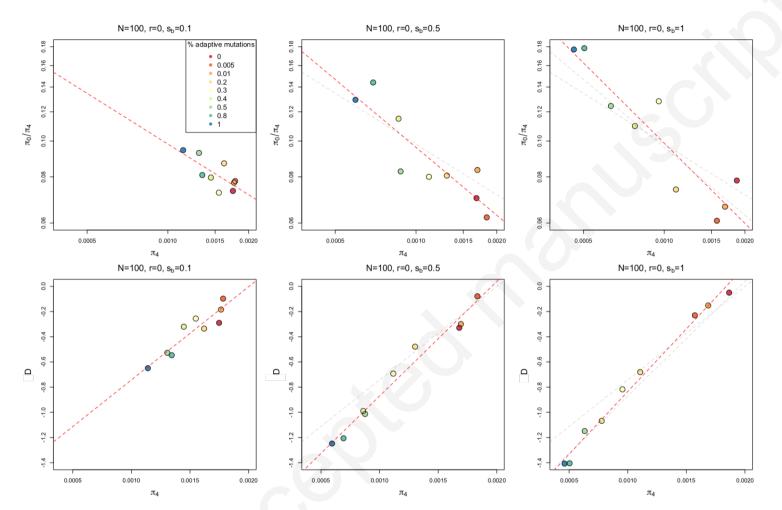


**Fig. 2** The regression of  $log(\pi_0/\pi_4)$  over  $log(\pi_4)$  for self-fertilizing *Arabidopsis thaliana* (dots) and its outcrossing relative *A. lyrata* 

977 (triangles).

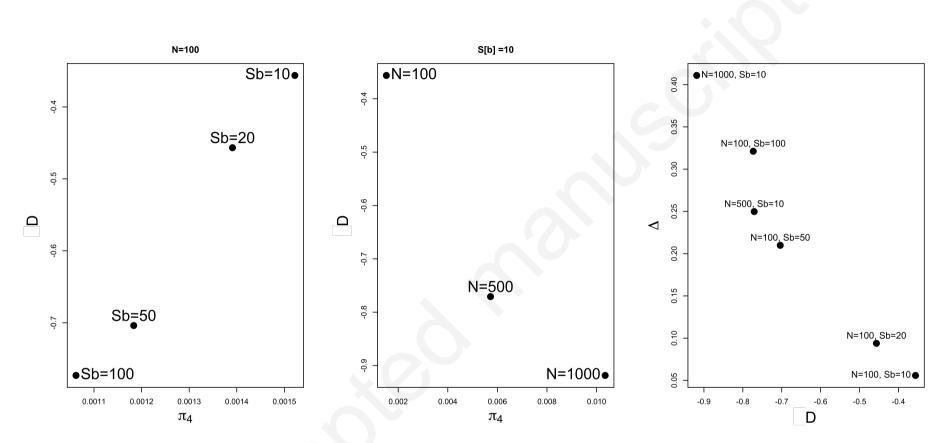


**Fig. 3** The relationship between  $\Delta$  (=*b*- $\beta$ ) and effective population size, N<sub>e</sub>, selective strength, *S<sub>b</sub>*, Tajima's D and the trend of D across bins  $\rho_D$  for 11 selected species. Dotted lines showed the linear regression line.  $\beta$  and *S<sub>b</sub>* values were estimated from full DFE models with both deleterious and beneficial mutations considered (full DFE model with both gamma and exponential distributions).
