# The effects of exercise training on plasma volume variations: A systematic review

#### Abstract

The aim of this systematic review was to summarize the evidence on the acute and long-term effects of exercise training on PV, in both trained and untrained individuals and to examine associations between changes in \%PVV and change in physical/physiological performance. Despite the status of participants and the exercise duration or intensity, all the acute studies reported a significant decrease of PV (effect size: $0.85<\mathrm{d}<3.45$, very large), and ranged between $7 \%$ and $19.9 \%$. In untrained individuals, most of studies reported a significant increase of PV in response to different kind of training including endurance training and high intensity interval training (effect size: $0.19<\mathrm{d}<3.52$, small to very large), and ranged from $6.6 \%$ to $16 \%$. However, in trained individuals the results are equivocal. We showed that acute exercise appears to induce a significant decrease of PV in both healthy untrained and trained individuals in response to several exercise modalities. Moreover, there is evidence that long-term exercise training induced a significant increase of PV in healthy untrained individuals. However, it seems that there is no consensus concerning the effect of long-term exercise training on PV in trained individuals.

## Introduction

Sports and physical exercise are important elements of lifestyle which are considered beneficial for overall health [1] and there is a large global interest in competitive sports [2]. Improving aerobic performance is key in many sports as well as being importance in overall health [3]. Aerobic performance depends on many different factors related to physiological parameters,
such as cardiac output ( Q ) and blood volume ( BV ) [4]. It is commonly accepted that Q represents a major limiting factor to high-intensity aerobic performance. The aerobic contribution could reach 30 to $45 \%$ during an all-out exercise such as 30 s-wingate test and represents a greater proportion during repeated sprint exercise [5]. The Q is determined by heart rate, myocardial contractility, and end-diastolic volume, which is influenced by total BV [6-8]. In this context, BV and hemoglobin $(\mathrm{Hb})$ concentration play important roles in oxygen transport and aerobic capacity (e.g. maximal oxygen uptake $\left[\dot{\mathrm{VO}}_{2 \max }\right]$ ) [8,9]. As such, the oxygen delivery appears to be the main determining factor of performance during aerobic physical exercise [10]. Alterations in $[\mathrm{Hb}]$ and red cell volume are known to be linked to changes in blood volume (BV). Kanstrup et al. [11] demonstrated that an increase in endurance performance and $\mathrm{VO}_{2^{\max }}$ occurs when hypervolemia is associated with an elevated [ Hb ], but not with reduced [ Hb ]. However, other investigations have showed that $\mathrm{VO}_{2^{\max }}$ can be increased in response to a BV expansion independent of changes in red blood cells (hypervolemic anemia) in untrained individuals [8,12-14].

Moreover, in a critical review, Sawka et al. [15] showed that BV changes occur with human adaptations to physical exercise, environmental stresses, and trauma/illness and as such that erythrocyte volume and plasma volume will change independently of each other and make separate contributions to each adaptation [15]. Warburton et al. [8] also performed a critical review to determine the potential ergogenic properties of volume loading and concluded that volume loading does not result in an improvement in $\mathrm{VO}_{2 \max }$ and/or endurance performance in endurance athletes. That is, volume loading in untrained individuals may improve $\mathrm{VO}_{2 \max }$, but does not bring these individuals to the aerobic capacity of endurance-trained athletes.

Within the blood components, plasma and haemoglobin/erythrocytes are the key transporters of nutrients and oxygen to active muscles [15,16]; therefore, it is logical that changes in plasma volume (PV) observed after exercise training could affect aerobic performances [8, 15; 17]. Indeed, several studies have demonstrated that induced PV expansion was accompanied by an increase in aerobic exercise performance capacity [17-19]. PV variations (PVV) depends on several intrinsic and individual factors, such as sex [20], age [21], training level [22], acute exercise duration [23], environmental factors [24] and exercise intensity [25] (figure 1). However, hematological and biochemical parameters may vary depending on the type, severity, duration of exercises, and feeding status [26-28]. The Hb and hematocrit (Hct) values of athletes subjected to intensive exercise programs, characteristically, decrease and this status is regarded as sportsman anemia [29].

Endurance training necessarily leads to adaptations in the cardiovascular system [30]; indeed, many studies have demonstrated that endurance training results in increases in Q , increased vascular conductance, and a greater oxygen extraction, with a consequential increase in aerobic power [31]. The increase in heart rate is responsible for the majority of Q augmentation during exercise; however, maximal heart rate is relatively unaltered with exercise training, with some evidence indicating that heart rate may be reduced during maximal exercise as a chronic training adaptation [32].

Many studies have examined the relationship between PVV, BV variations and performances in response to acute and/or chronic exercise [16, 33, 34]. Previous studies have reported that improved endurance performance was accompanied by increases in PV and decreases in Hct [33]. Since physical exercise and training induces changes in PVV levels, it is important to investigate and understand PVV levels in response to acute and log-term exercise training. Accordingly, we conducted, a systematic review of the effects of acute exercise and long-term exercise training on PVV levels in untrained and trained individuals. Moreover, we examined associations between changes in \%PVV and changes in physical/physiological performance.

## Methods

This systematic review was conducted in accordance with the Preferred Reporting Items for Systematic Reviews and Meta- Analyses (PRISMA) Statement [35]. The PICOS approach (Population, Intervention, Comparator, Outcomes, Study design) was followed to identify inclusion criteria (Table 1). Only randomized controlled trials and controlled trials that examined the acute and chronic effects of training on plasma volume variations (PVV) in trained and healthy untrained individuals were eligible for inclusion. Studies were included in the current systematic review if they were in accordance with the following criteria: (1) published in peer-reviewed journals; (2) included participants 16 years or older; (3) involved trained and/or untrained individuals; (4) used validated methods of PVV measurements; (5) used exercise testing sessions for cross-sectional studies and, in the case of intervention studies, exercise training programs; and (6) all interventions lasted a minimum of 1 weeks (only for long-term exercise training studies). Studies were excluded if they (1) did not meet the minimum requirements of an experimental study design (e.g. case reports), (2) did not meet the minimum requirements regarding training design (e.g. lack of information on volume, frequency, and/or training methodology), (3) were not written in English, or (4) involved individual with diseases. Moreover, review articles were not included in the current systematic review.

Literature searches were conducted in four electronic databases, including PubMed, ISI Web of Knowledge, Web of Science, and SPORTDiscus, from database inception until December 2020. The following key terms (and synonyms searched for by the MeSH database) were included and combined using the operators "AND", "OR", and "NOT": ((exercise OR "exercise training*" OR "high-intensity interval training*" OR "high-intensity interval exercise*" OR "high-intensity intermittent training*" OR "high-intensity intermittent exercise*" OR "interval aerobic training*" OR "interval aerobic exercise*" OR "aerobic interval training*" OR "aerobic interval exercise*" OR "intermittent aerobic training*" OR "intermittent aerobic exercise*" OR "high-intensity training*" OR "high-intensity exercise*" OR "sprint interval training*" OR "sprint interval exercise*" OR "strength training*" OR "resistance training*" OR cycling) AND ("physical fitness" OR "physiological adaptation" OR "physiological response" OR "heart rate" OR "oxygen uptake" OR VO2 OR "maximal oxygen uptake*" OR "VO2max" OR "aerobic performance" OR "endurance performance" OR "sprint performance" OR "strength performance" OR "cycling performance") AND (plasma OR "plasma volume" OR "plasma volume variations" OR VVP OR blood OR "blood volume" OR "hematological parameters" OR "hematocrit" OR "Hct" OR "hemoglobin" OR "Hgb" OR "Hb")). In addition, the reference lists and citations (Google Scholar) of the identified studies were explored in order to detect further relevant research papers that may have inadvertently been omitted. Since the scope of this review article is large in terms of outcome measures (e.g. performance, physiological adaptations, health indices), a systematic review, but a meta-analysis was not conducted (i.e., the large number of outcome parameters would have yielded high heterogeneity).

In the current review, only studies using a direct or a valid indirect method to estimate PVV were included. For indirect method, changes in whole blood volume (WBV), red cell volume (RCV) and plasma volume (PV) were calculated from the values obtained for haemoglobin concentration and packed cell volume (PCV) before and after acute exercise or long-term training programs, using the calculations described by Dill and Costill [36]. The equation of Beaumont [37] which has been used to calculate changes in PV on the basis of haematocrit values alone is not applicable as it depends upon a constant red cell volume being maintained [38]. Thus, studies using Beaumont equation only were not included in the present study.

The final screening was performed by two investigators (FR and AJ) based on the relevance
of the inclusion and exclusion criteria and the identified items for assessing the effects of acute and chronic physical exercise on PVV in trained and healthy untrained individuals using PICOS criteria. If the citation showed any potential relevance, it was screened at the abstract level. When abstracts indicated potential inclusion, full-text articles were reviewed. A third-party consensus meeting was held with a third author (HZ), if the two reviewers were not able to reach agreement on inclusion of an article.

The methodological quality of the included studies was assessed using the Physiotherapy Evidence Database (PEDro) scale (Hcttp://www.pedro.fhs. usyd.edu.au), which has been shown to have good reliability and validity [39]. The PEDro scale has 11 possible points that examine external validity (criterion 1) and internal validity (criteria 2-9) of controlled trials and whether there is sufficient statistical information for interpreting results (criteria 10-11). A cut-off points of 6 on the PEDro scale was used to indicate high-quality studies, as this has been reported to be sufficient to distinguish high quality vs. low quality in previous studies [39]. Two independent researchers (FR and AJ) assessed the quality of the studies, if any ambiguity arose, a third researcher (HZ) was contacted and a unanimous decision was achieved.
To evaluate the magnitude of the effects, percent change ( $\Delta \%$ ) was calculated (if not available in the individual studies) for each study using the following equation:

Where Mpost represent the mean value after (acute exercise or long-term of training) and Mpre the baseline mean value.

Effect sizes (ES) were computed to present standardized effect of acute and long-term training on the outcome variables (e.g. PVV and physical performances). The different ES were calculated using Cohen's d [40] by dividing the raw ES (difference in means) by the pooled standard deviations:

Values for ES were defined as trivial (<0.2), small (0.2-0.6), moderate (0.6-1.2), large (1.22.0 ), and very large $>2.0$ [29]. Results for each outcome variable are presented with number of observations (N) of $\Delta \%$ and ES calculated within the review. All data analysis was processed using Sigma Stat 3.5 software (Systat, Inc, USA). Mean percentages of change at different time points extracted from all studies were presented as mean (Range: minimum and maximum) for all parameters. The ES and $\Delta \%$ were analyzed in studies where sufficient data was available. A significant difference was indicated when the $95 \%$ confidence interval
(CI) of the ES did not overlap with zero. In addition, the relationships between $\Delta \%$ of PVV and $\Delta \%$ of physical/physiological performance were assessed where sufficient data was available using Pearson's product-moment correlation coefficients (r). The magnitude of correlation coefficients were considered as trivial ( $\mathrm{r}<0.1$ ), small ( $0.1<\mathrm{r}<0.3$ ), moderate ( $0.3<\mathrm{r}<0.5$ ), large ( $0.5<\mathrm{r}<0.7$ ), very large ( $0.7<\mathrm{r}<0.9$ ), nearly perfect ( $0.9<\mathrm{r}<1.0$ ), and perfect $(r=1.0)$ [40]. Statistical significance for all analyses was set at $\mathrm{p}<0.05$.

## Results

Overall, our search identified 3349 records (figure 1). After screening of titles, abstracts and full texts, 30 studies were included in our final analysis. Table 2 illustrates characteristics of the 9 acute and 21 long-term studies. The 15 acute studies [16, 19, 21-22, 33, 41-50] were performed in 6 different countries (France, Japan, Canada, Brazil, United States and United Kingdom) and involved 269 participants. Different kinds of exercise activities (walking, cycling and running) with different durations ( 30 s to $>1 \mathrm{~h}$ ) and intensities (maximal and supramaximal) were used.

The 25 included long-term studies were classified as 'high-quality' studies (mean 6.7 in the PEDro scale score), and only six studies were classified as 'low-quality' study (mean 3.8 in the PEDro scale score) [1,4 8-49, 51, 52, 53] (Table 3). A total of 474 participants underwent exercise-training programs and completed the studies. The 25 long-term studies were carried out in different countries from five continents (Australia, France, Sweden, United Kingdom, Japan, Poland, Qatar, Switzerland, Denmark, Austria, Tunisia, Iran, Germany and USA). Nine studies investigated both male and female subjects, 15 studies investigated male subjects and 1 study involved only women [54]. Fifteen studies investigated healthy trained participants and 10 involved untrained individuals. The training duration was at least 5 to 8 days [53, 55, 56], for several studies it was around between 3 and 8 weeks, for some studies it was around 3 months and for one study the duration was 6 months [57].

Table 4 summarizes the acute effects of exercise on PVV in trained and untrained individuals. Five studies [16, 33, 42, 44-45] were identified that examined the acute effects of exercise on

PVV in moderately trained subjects. Two studies [19, 22] involved highly trained endurance and sprint athletes. Despite the status of participants and the exercise duration or intensity, all the studies reported significant decrease of PV (effect size: $0.85<\mathrm{d}<3.45$, very large). The decreases were ranged between $7 \%$ [33] and $19.9 \%$ [19]. Only one study [41] observed an increase ( $+7.3 \%$ ) of PV after 28-mile walk in hill walkers.

Ten studies investigated the effect of long-term training on PVV in healthy untrained men and women (Table 5). Most of studies reported significant increase of PV in response to different kind of training including endurance training and HIIT (effect size: $0.19<\mathrm{d}<3.52$, small to very large). The increase was ranged from $6.6 \%$ [58] to $16 \%$ [59]. The study of Mtinangi and Hainsworth [60] investigated the effect of 3 months of a combination of strength and endurance training in both men and women and reported an increase of 230 mL of PV (effect size: 1.58, very large). However, Green et al. [61] reported $10 \%$ increase of PV after 8 weeks of cycling at $62 \% \dot{\mathrm{~V}}_{2 \text { max }}(2 \mathrm{~h} / \mathrm{d})$ in men (effect size: 2.71 , very large). In untrained individuals, there was no significant correlation between change in \%PVV and change in physical/physiological performance.

Table 6 depicted the 15 studies that investigated the effects of long-term exercise training PVV in trained individuals. Seven studies observed a significant increase of PV ( $4.6 \%$ to $10 \%$; effect size: $0.15<\mathrm{d}<1.35$, small to large) in moderately or highly trained individuals, men and women in response to endurance training [34, 55, 62, 63], HIIT [16, 33] and combined training [43]. Three studies observed no significant changes of PV in response to an interval walking training ( 5 sets at high intensity ( $>70 \% \dot{\mathrm{~V}}_{\text {2peak }}$ ) and slow at $40 \% \dot{\mathrm{~V}}_{\text {2peak }}$ ) in active men and women [45], or to sprint training in untrained men [57], or to endurance altitude training (21 nights simulated live high at 3000 m ) in men and women endurance trained athletes [63], or to HIIT at $90-95 \% \mathrm{HR}_{\text {max }}$ in well-trained sport students [64] (effect size: $0.22<\mathrm{d}<2.79$, small to large) or to weightlifting in trained men [65] and to altitude training in men and women world class endurance athletes [66]. Two studies reported a significant decrease of PV in response to combined training in track and field 400M athletes [1] and in response to 21 days of endurance altitude training camp in international level road cyclists [10] (effect size: $0.84<\mathrm{d}<1.00$, large).

In trained individuals, there was no significant correlation between change in \%PVV and change in physical/physiological performance.

## Discussion

To the best of our knowledge, the current review is the first systematic review aiming to study the effects of acute exercise and long-term exercise training on plasma volume variations levels in untrained and trained individuals. The results showed that acute exercise appears to induce a significant decrease of PV in both healthy untrained and trained individuals in response to several kind of exercise activities. Moreover, there is evidence that long-term exercise training induces a significant increase of PV in healthy untrained individuals. However, there is no consensus concerning the effect of long-term exercise training on PV in trained individuals.

Recently, only Sawka et al. [15] in their review examined critically the influence of several perturbations (physical exercise, environmental (heat, terrestrial altitude, microgravity, stress, and trauma/sickness) on blood volume. They found that blood volume changes occur with adaptations to physical exercise, environmental stresses, and trauma/illness [15]. More specifically, these authors showed that blood volume increases over time with exercise training and that PV expansion can occur within 24 h and during the first 2 weeks of exposure accounts for nearly all of the blood volume expansion response [15]. However, Sawka et al. [15], the authors did not take into account neither the individual status (trained vs. untrained) nor the duration of exercise (acute exercise vs. long-term exercise training).

Consistent reports on the effect of acute exercise on PVV have been shown, where, despite the status of participants and the exercise duration or intensity, significant decreases of PV are demonstrated $[16,19,21,22,33,43,44,50]$. In adult male subjects, Berthoin et al. [21,50] and Zouhal et al. [19] reported a significant reduction in PV from baseline after very strenuous exercise. Several factors such as gender [20], age [21] and the level of training of subjects [22] influence the amplitude of the PVV. For all these factors, it seems that the intensity of exercise plays a major role in this decrease. For example, Berthoin et al. [49] reported in adult men a maximum fall of $17.2 \pm 3.5 \%$ following a supramaximal exercise at $120 \%$ of maximal aerobic speed (e.g., velocity eliciting maximal oxygen uptake). These values are slightly higher than those observed in other studies such as that of Hebestreit et al. [50] who found in male physical
education and sports students, three minutes after a 30 -second Wingate exercise, a $16 \%$ drop in PV. However, Zouhal et al. [19] indicated that the level of training also affects the magnitude of the PVV. These last authors measured a maximum fall of $-19.97 \pm 3.05 \%$ in athletes specialized in sprinting, $-9.45 \pm 3.05 \%$ in endurance athletes and $-9.05 \pm 3.31 \%$ in sedentary subjects after a 30 second Wingate. Moreover, Derbré et al. [57] measured a maximum fall of $-9 \%$ in adolescents after a 6 -second sprint test carried out on an ergometric bicycle. Accordingly, the values of PVV did not differ before and after training, and even after detraining.

The aging process impairs balance of fluids and electrolytes [67, 68], leading to reduced PV among elderly individuals [69]. Intensity dependent PV losses have been reported in response to exercise lasting 6 min [70] and 20 min [71] and changes of similar magnitude have been previously reported following sprinting [67, 72-75]. Moreover, changes (12.5\%) in PV postwarmup were followed by a further $5.5 \% \mathrm{PV}$ reduction immediately post-sprint, reinforcing the potential influence of intensity of exercise on PV change. Although the literature is sparse with respect to the effect of duration of maximal-intensity exercise on PV change, Stokes et al. [76] reported larger decreases in PV 5 min after a 30 -s sprint ( $14.8 \%$ ) when compared with a 6 -s sprint (5.1\%). Finally, 20 min after this exercise (sprinting), PV losses were still evident. The persistence of reductions in PV during recovery from sprinting is probably related to water movements into previously exercised muscles [77] probably due to sustain vasodilation [78-80] and is consistent with other studies adopting similar exercise protocols [72, 76].

According to the majority of reports, the hemoconcentration observed after acute exercise is influenced by several factors: 1.) Sweating induced fluid loss, which plays an essential role in moderate-long duration endurance exercise [81-82], however, it is likely not implicated in sprinting exercise; 2.) The increase in hydrostatic pressure, secondary to the rise in blood pressure which promotes extravasation of water out of the capillaries [83-84]; 3.) An increase in osmotic pressure, secondary to the accumulation of metabolic by-products ( $\mathrm{H}^{+}$ions, lactate, ammonium, $\mathrm{K}+$, etc.) especially following sprint exercise [85]; and, 4.) The response of the hormones that control the electrolyte balance including aldosterone (ALD), antidiuretic hormone (ADH) and atrial natriuretic factor (ANF) [85].

Jabbour et al. [86] showed that after HIIT, the acute PVV decreased were attenuated compared to those observed before HIIT program. Mtinangi and Hainsworth [60] showed that PVV increased after 2-3 months of exercise training using the 5BX/XBX Royal Canadian Air Force program. In this context, Jabbour et al. [86] showed less change in PV in response to a warm-
up after HIIT. Similar results have been reported in response to long-term or relatively shortterm continuous exercise training [53, 62, 87, 88]. Convertino et al. [53] showed that PVV increase by $+12 \%$ after 8 days of graded training on ergometer cycle at $65 \% \dot{\mathrm{~V}}_{2 \text { max. }}$. Similarly, Carrol et al. [87] showed that PVV increases by $+11 \%$ after endurance training for 26 weeks at $40-80 \% \operatorname{HR}_{\text {max }}$. Recent studies have shown also significant increase in PVV by $8 \%$ after HIIT cycling at $40-50 \%$ HR [77], by $+16 \%$ after endurance training at $50-70 \%$ of maximal aerobic velocity (MAV) [59] and by $+6 \%$ after cycling exercise training at $60-75 \% \dot{V}_{2 \text { peak }}$ [58].

Most studies showing PV increases have been conducted in physically fit populations (i.e., athletes, active subjects) and they have evaluated the training effects on PV variations reported a significant increase in PV in response to exercise [77]. According to Mtinangi and Hainsworth [60], subjects that had higher initial plasma and blood volumes and (i.e., if the peak recorded oxygen uptake is regarded as a measure of fitness), would also the fittest subjects before starting to train. However, the increase in PV has been proposed as a risk factor that could worsen the symptoms of hypertension by increasing the mean circulatory filling pressure due to decreased total vascular compliance, and increasing venous rerun to the heart/cardiac output, resulting in the renal adaptation and an upward shift of the set point of arterial pressure [60].

Silva et al. [89] showed that PV decreased by $11.2 \%$ after 12 weeks of specific soccer training and was significantly correlated to the alteration percentage of Hb and Hct changes. In contrast, Heisterberg et al. [90] recorded no significant changes in Hb and Hct levels over a 6-months period in which the training and match load varied considerably. Indeed, PV measured after a 6 -week period of match congestion was significantly higher ( $+6.1 \%$ ).

Gibala et al. [91] showed that a short-training period involving high intensity intermittent exercises may result in significant variations of PV. Green et al. [92] showed that PV increased by $11.6 \%$ in response to three consecutive days of intermittent supramaximal interval cycling exercise in moderately trained subjects. According to data provided by Mtinangi and Hainsworth [60], significant increases in PV were reported after 2-3 months of exercise training using the 5BX/XBX Royal Canadian Air Force program. Furthermore, Alis et al. [93] reported higher PV loss in response to high intensity training protocol for 10 healthy men compared to aerobic running exercise. It has been shown that high intensity training results in a sufficient decrease in PV to increase plasma constituent concentrations [86]. Two main mechanisms may explain the increase in PV with training. The first, of two phases, occur with plasma proteins increases, especially albumin [94]. In fact, when plasma protein concentration increases, the oncotic pressure increases, and fluid is reabsorbed from the interstitial fluid into the blood
vessels [53, 85, 94]. Thus, the increase of plasma albumin is responsible of the first phase of rapid PV increase, which occurs after the first hour of recovery from an exercise training session [89]. During the second phase, protein synthesis is upregulated by repeated exercise exposure, and new plasma proteins are formed. The second mechanism is the secretion of hormones that cause reabsorption of water and sodium in the kidneys, which increases blood plasma, namely antidiuretic hormone and aldosterone [53, 85, 94]. The oncotic pressure exerted by the proteins keep this increased fluid in the vascular space. Nearly all of the increase in blood volume during the first 2 weeks of training can be explained by this increase in plasma volume [53, 85, 94]. It has been demonstrated that the enhancement of aerobic exercise performance is associated with an increase in BV, which consists in a PV increase [8, 15, 53, 95-98]. Carroll et al. [87] showed a significant increase of PVV accompanied by an increase of $\dot{\mathrm{V}}{ }_{2 \text { max }}(+11.2 \%)$ after 26 weeks of endurance training program. Gibala et al. [96] showed that 3 to 6 of HIIT sessions for 2 weeks could significantly increase endurance performances.

More recently, Ben Abderrahaman et al. [33] showed a significant increase of $\dot{\mathrm{V}} \mathrm{O}_{2 \text { max }}$ and MAV and a significant correlation after HIIT between PVV and (i) $\dot{\mathrm{VO}}_{2 \max }(\mathrm{r}=0.76)$ and (ii) MAV $(r=0.60)$. Kataoka et al. [58] showed that PVV increased by $+6 \%$ after cycling exercise training at $60-75 \% \dot{\mathrm{~V}}_{2 \text { peak }}$ accompanied by $+13 \%$ of improvement in $\dot{\mathrm{V}} \mathrm{O}_{2 \text { peak }}$ performances. In addition, Jabbour et al. [78] showed that PVV increased by $+8 \%$ after HIIT cycling at $40-50 \%$ HR. Montero et al. [59] showed that PVV increased by $+16 \%$ after endurance training at 50$70 \%$ MAV accompanied by $+11 \%$ of MAV performances improvement. Similarly, Rhibi et al. [16] showed a significant correlation after HIIT between PVV and TTE. In contrast, several studies conducted with endurance athletes and soccer players showed significant negative correlations between Hct and measures of physical fitness, suggesting increased performance with a decreasing Hct value [98-99]. In fact, changes in PV independent of Hb have more complicated effect on both $\dot{\mathrm{V}}_{2 \text { max }}$ and endurance performance due to the concomitant hemodilution effect [16, 90].

## Limitations

The limitation of the current review is that several studies dealing with the effect of a long-term exercise training on PVV used the indirect method (e.g., Dill and Costill method [36]). The indirect methods available have clear disadvantages when judging PV change because RCV and the number of erythrocytes cannot assumed to be constant. The method described by Dill and Costill can be accurate for acute exercise responses but not for a long-term exercise training effects. In fact, Dill and Costill's description of the RCV-space assumes an unaltered number
of erythrocytes in the circulation which can hardly be expected in the long-term exercise training. Thus, this is a clear limitation of the Dill and Costill method. Most certainly more studies using more accurate and precise methods to describe PVV after long-term exercise training are needed.

## Conclusion

This systematic literature review demonstrates that acute exercise appears to induce a significant decrease of PV in both healthy untrained and trained individuals in response to several kinds of exercises. Furthermore, there is evidence to suggest that long-term exercise training can also induce a significant increase of PV in healthy untrained individuals. However, there is currently no consensus concerning the effect of long-term exercise training on PV in trained individuals. Therefore, further studies are needed to investigate the effects of long-term exercise training on PV in highly trained athletes, especially those associated with high intensity endurance training, sprint training, strength training.
