One-pot synthesis of *N*-fused benzimidazo-β-carbolines through sequential propargylation/*aza*-cycloisomerization approach

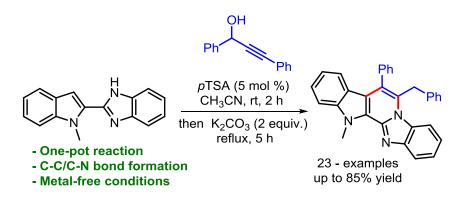

ABSTRACT: The first sequential acid-catalyzed propargylation/base-mediated *aza*cycloisomerization between indolyl-benzimidazoles and propargylic alcohols is described. This protocol enables the one-pot construction of *N*-fused benzimidazo- β -carbolines in good yields. The synthetic utility of this approach is demonstrated by the assembly of an *aza*helicene and also by a gram scale reaction.

KEYWORDS: Propargylation • aza-annulation • β -carboline • Propargylic alcohol • Cycloisomerization

INTRODUCTION

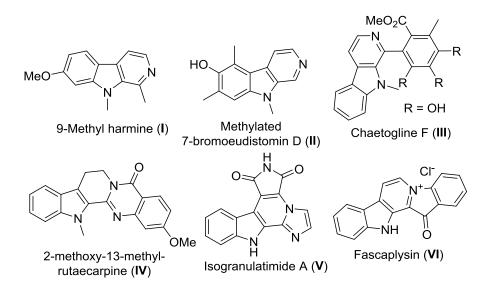
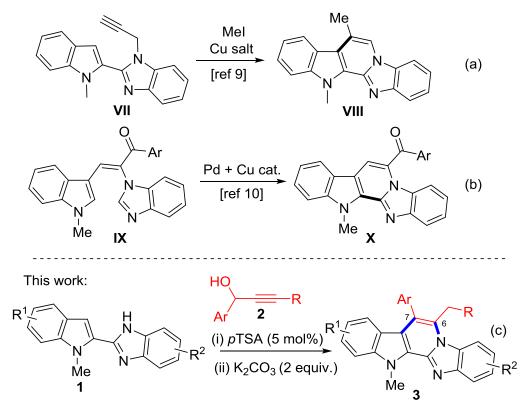


Figure 1: Representative examples of β -carboline and *N*-fused β -carboline

β-Carbolines are one of the important scaffolds embedded in many bioactive natural products and/or pharmaceutical agents, such as 9-methyl harmine (**I**), methylated 7-bromoeudistomin D (**II**), Chaetogline F (**III**) etc. as representative examples (Figure 1).¹⁻⁴ Further, *aza*heterocyclic fused β-carbolines are also encountered as key motifs with important pharmacological properties (Figure 1). For instance, 2-methoxy-13-methyl-rutaecarpine (**IV**, fused quinazoline tetrahydro-β-carboline) alkaloid exhibits significant anti-malarial activity,⁵ Isogranulatimide A (**V**, fused imidazole β-carboline) showcases a G2 Checkpoint Inhibitor⁶ and Fascapsylin C (**VI**, fused β-carboline) displays strong cytotoxic activity against leukemia cells.⁷ Benzimidazole is also one of the frequent heterocycles in pharmaceuticals. Therefore, we became interested to explore the construction of a novel hybrid skeleton, *N*-fused benzimidazo-β-carboline.⁸ To the best of our knowledge, there are only two methods known in the literature towards the synthesis of benzimidazo-β-carbolines with limited examples. In the first method, copper-catalyzed intramolecular cyclization of *N*-propargylated benzimidazole **VII** provides the corresponding benzimidazo-β-carboline **VIII**

(Scheme 1a).⁹ The other method involves a transition metal-mediated C-C bond formation of indolyl-propenone **IX**, generated by the Knoevenagel condensation between azoles and indole carboxaldehydes, to give benzimidazo- β -carboline **X** (Scheme 1b).¹⁰ Hence, a general and efficient method for the construction of diversely substituted benzimidazo- β -carbolines remains desirable.

On the other hand, 1-aryl propargyl alcohols have emerged as effective precursors in sequential nucleophilic substitution/annulation reactions for the assembly of heterocycles as well as carbocycles.¹¹ Based on our previous research on the use of propargylic alcohols as reaction partners in annulation reactions,¹² we anticipated their reactivity with easily accessible indolyl-benzimidazoles (1) to offer targeted *N*-fused benzimidazo- β -carbolines (3). Herein, we describe the first sequential propargylation/*aza*-cycloisomerization approach for the assembly of *N*-fused benzimidazo- β -carbolines (Scheme 1c).

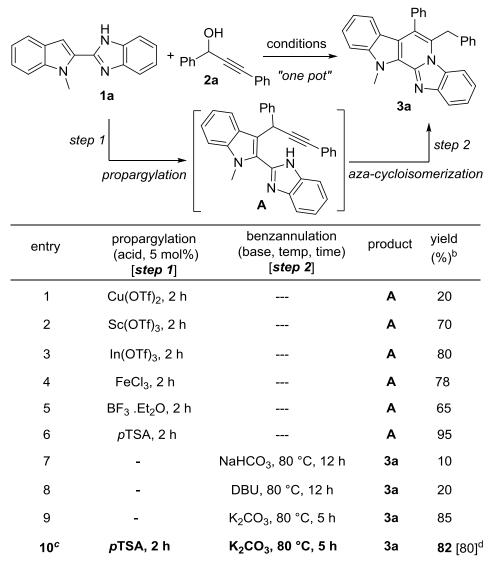


Scheme 1: Synthesis of *N*-fused benzimidazo- β -carbolines

RESULTS AND DISCUSSION

The indolyl-benzimidazole **1a** and propargylic alcohol **2a** were selected as model substrates to explore the feasibility of the envisaged propargylation followed by *aza*-cycloisomerization and to further optimize the reaction conditions (Table1). Initially, various acid catalysts were screened for the propargylation of **1a** with **2a**. Among triflates, copper (II) triflate gave poor yield of **A** (20%, entry 1) whereas scandium (III) triflate gave satisfactory yield of 70% (entry 2). Indium (III) triflate performed well affording the intermediate **A** in 80% (entry 3).

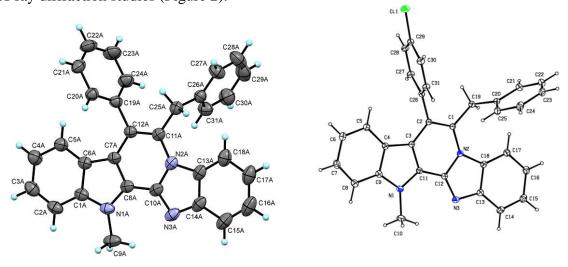
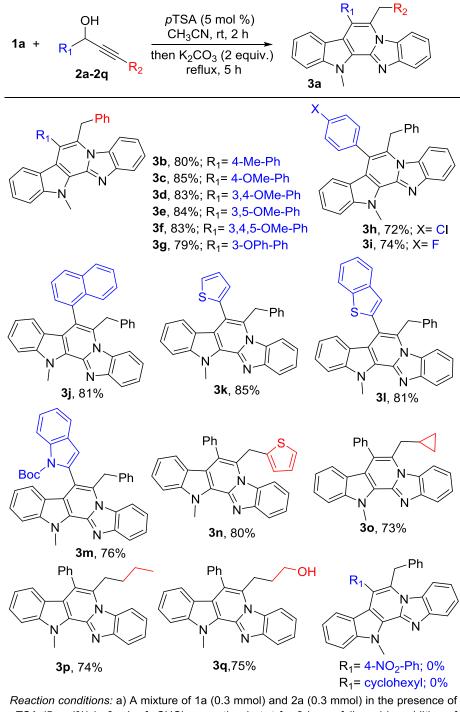


Figure 2: X-ray structure of **3a** (CCDC No. 2309870) and **3h** (CCDC No. 2326484) Having defined the optimal reaction conditions, we probed the scope and limitations of this one-pot protocol. Initially, the scope of propargylic alcohols was studied and the results are shown in Scheme 2. As expected, the propargylic alcohols with electron-rich aryl (\mathbb{R}^1)

FeCl₃ gave a promising yield of **A** in 78% (entry 4) and BF₃.Et₂O was found to be less efficient (65% yield of **A**, entry 5). To our delight, *p*-toluene sulfonic acid (*p*TSA) proved to be the best catalyst for the C-propargylation to afford **A** in 95% yield (entry 6). Having the successful formation of C3-propargylated indole derivative **A**, its *aza*-cycloisomerization was tested using different bases. Sodium bicarbonate gave expected fused β -carboline **3a** in 10%, (entry 7) and DBU proved to be equally inefficient for this reaction (20% yield of **3a**, entry 8). To our satisfaction, potassium carbonate was the base of choice for this *aza*-annulation and subsequent isomerization affording the target molecule **3a** in 85% yield (entry 9). Next, a one-pot conversion *via* a sequential addition of *p*TSA followed by K₂CO₃ was also attempted and we were pleased to obtain **3a** in an overall yield of **82%** (entry 10). We have also tested the scalability of the reaction on gram scale (4 mmol of **1a**) to afford **3a** in 80% yield (1.41g). The structure of benzimidazo- β -carboline **3a** and **3h** were also established by single-crystal X-ray diffraction studies (Figure 2).

substitutions holding methyl, methoxy and phenoxy groups performed well in this one-pot transformation affording the desired *aza*-fused benzimidazo- β -carbolines **3b** to **3g** in good

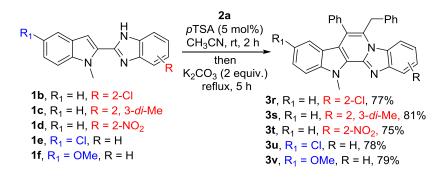

yields. Halogen substituted propargylic alcohols also gave the products **3h** and **3i** in 72% and 74% yields, respectively. Propargylic alcohol generated from 1-naphthaldehyde suited well to offer the corresponding fused β -carboline **3j** in 81% yield. Likewise, the heterocyclic substrates containing thiophene, benzothiophene and *N*-Boc-indole rings found to be well suited, affording the corresponding products **3k** to **3m** in good yield. As far as the other side of the propargylic alcohol is concerned (R² group linked to the alkyne), all the studied substrates were successful in providing the desired products. A thiophene group on the alkyne was perfectly compatible with the reaction, providing **3n** in 80% yield. Similarly, a cyclopropylated alcohol gave the annulated β -carboline **3o** in 73% yield while the propargylic alcohols having *n*-propyl group on the alkyne offered the product **3p** in 74% yield. The substrate with *tert*-butyldiphenylsilyl ether was also participated in this one-pot reaction affording the desilylated β -carboline **3q** in 75% yield. Not surprisingly, the substrates generated from 4-nitro benzaldehyde (electron-withdrawing group) and aliphatic aldehydes were found to be ineffective for acid-catalyzed propargylation reaction, which can be attributed to the formation of non-stabilized carbocation intermediate.

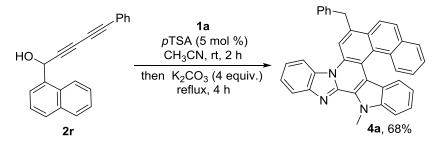
Next, we turned our attention to verify the substrate scope pertaining to the indolylbenzimidazoles (Scheme 3). Substitutions (electron-donating as well as electronwithdrawing) on the benzimidazole ring such as chloro (1b), dimethyl (1c) and nitro (1d) groups were well tolerated in reaction with 2a providing the fused benzimidazo-carbolines 3r



Scheme 3: Scope and limitations regarding benzimidazole and indole moieties

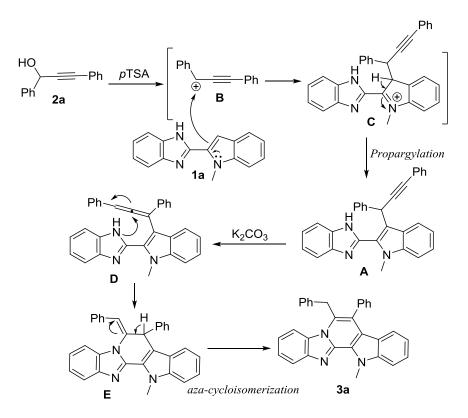
(77%), **3s** (81%) and **3t** (75%), respectively. Similarly, the effect of substitutions on the indole ring was also tested. The substrates having chloro (**1e**) and methoxy (**1f**) groups on indole participated in reaction with **2a** affording **3u** (78%) and **3v** (79%), respectively.

To further examine the versatility of this one-pot strategy, we investigated the reaction of diyne-ol 2r with 1a anticipating a double annulation. To our pleasure, the sequential propargylation/*aza*-cycloisomerization/benzannulation was feasible to deliver the corresponding *aza*-helicene 4a in 68% yield (Scheme 4). The helicity of 4a was established by chiral HPLC analysis, which revealed the existence of a pair of enantiomers.

Based on the aforesaid outcomes and relevant literature reports,^{12c} a possible reaction mechanism is proposed (Scheme 5). Initially, carbocation **B** is generated from **2a** in the presence of *p*TSA which reacts with nucleophile **1a** leading to propargylated indole **A** *via* intermediate **C**. Then, base-promoted formation of allene intermediate **D** and subsequent intramolecular regioselective *aza*-cyclization produced the intermediate **E**. Lastly, intramolecular isomerization of **E** through 1,3-H shift under basic conditions furnished the desired product **3a**. The intermediate **A** was also isolated, characterized and independently treated with base to obtain the product **3a**.

CONCLUSION

In conclusion, we have developed a convenient and straightforward approach for the synthesis of unprecedented *aza*-fused benzimidazo- β -carbolines from readily accessible starting materials. The strategy involves a sequential acid-catalysed C-propargylation/base-mediated *aza*-cycloisomerization. A variety of 1-aryl propargylic alcohols as well as indolyl benzimidazoles are found to be competent participants. Furthermore, this protocol could be extended to diyne-ol leading to a double annulation process affording the fused carbo- and hetero-aromatic structural framework (helicene). With interesting advantages such as metal-free, operationally easy conditions, good substrate scope and yield of the products, this method would find application in organic synthesis.

EXPERIMENTAL SECTION

General information:

All the reactions were performed in oven-dried glass apparatus. For reactions sensitive to air and moisture, an inert atmosphere (nitrogen) was employed, and freshly distilled anhydrous solvents were used. Commercially available reagents (pTSA, K₂CO₃) were utilized without additional purification. Thin-layer chromatography performed on silica plates and visualized under UV light and anisaldehyde was used to monitor all reactions. Column chromatography, using hexane and ethyl acetate as the eluent, was carried out on silica gel (100-200 mesh). The ¹H NMR spectra were recorded in CDCl₃ at 500 and 400 MHz, while the ¹³C NMR spectra were recorded at 126 and 101 MHz. ¹H NMR was recorded in CDCl₃ at 400 and 500 MHz, and 13 C NMR was recorded at 126 and 101 MHz. δ 7.26, δ 77 and δ 2.5, δ 39.5 correspond to CDCl₃ and DMSO- d_6 in ¹H NMR and ¹³C NMR, respectively, and δ 1.56 and δ 3.3 are related to the moisture present in $CDCl_3$ and $DMSO-d_6$. Chemical shifts are reported in δ (ppm) relative to TMS as an internal standard, and J values are expressed in Hz. Multiplicity is denoted as s (singlet), d (doublet), t (triplet), m (multiplet), dd (doublet of doublets), etc. High-resolution mass spectra (HRMS) [ESI]⁺ were obtained using either a TOF or a double focusing spectrometer. Melting point of all solid compounds was determined using a melting point apparatus.

Procedures for the Preparation of Starting Materials:

All the basic starting materials $1a^1$ and 2a-2q and 2v, 2w and 2r were prepared based on literature reports² and the spectral data was compared.

General procedure for the preparation of indolyl benzimidazoles (1)

General procedure for the preparation of aza-fused benzimidazo- β -carbolines (3)

To the solution of indolyl benzimidazaole (1) (0.40 mmol, 1.0 equiv) in CH₃CN (3 mL), propargylic alcohol **2** (0.40 mmol, 1.0 equiv) and *p*TSA (0.02 mmol, 5 mol %) were added and stirred at rt for 2h affording intermediate **A**. It was further treated with K₂CO₃ (0.80 mmol, 2 equiv) and stirred at 80 °C in an oil bath till the completion of the reaction as indicated by TLC. The reaction mixture was diluted with water (10 mL) and extracted by EtOAc (10 mL x 2). The organic layers were combined, washed by water (10 mL x 2), and brine solution (10 mL), dried over Na₂SO₄, and concentrated under reduced pressure. The residue was purified by column chromatography on silica gel to afford substituted *N*-fused benzimidazo- β -carbolines (**3**).
